Review ALL the literature available to you before submitting your sanction, make sure the form is filled out correctly, make sure you understand your personal liability when signing the form, and enclose ONE (1) check for EACH sanction "TOTAL AMT" you submit. Return ALL COPIES of your completed forms together, with any 3rd Party Request Forms you need to submit, and your check payable to the WISCONSIN USA TRACK & FIELD, INC. Enclose a SASE with \$0.57 postage for quicker and accurate mailing for your sanction materials.

To request Sanction forms plan to RETURN YOUR COMPLETED FORMS NO LATER THAN FOUR (4) WEEKS IN ADVANCE OF YOUR EVENT or 3rd PARTY INSURABILITY REQUEST NEED DATE (USE THE EARLIEST DATE!). When you have established the date to request YOUR forms, send me the NAME of your event, DATE of the event, LOCATION of the event, and the ESTIMATED number of PARTICIPANTS.
